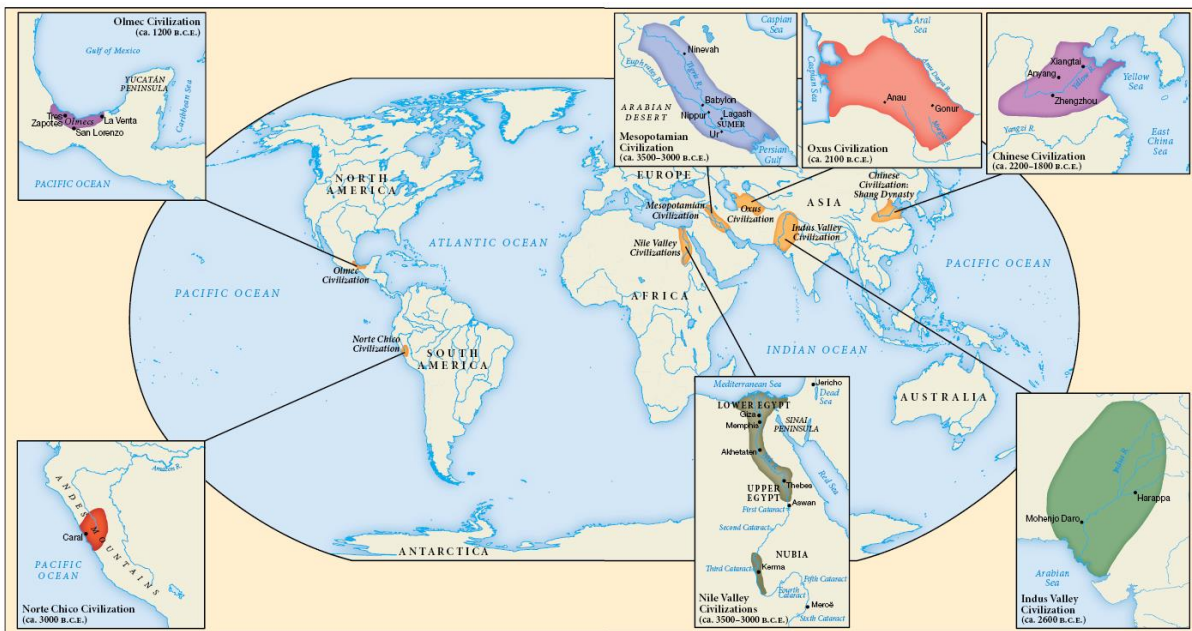

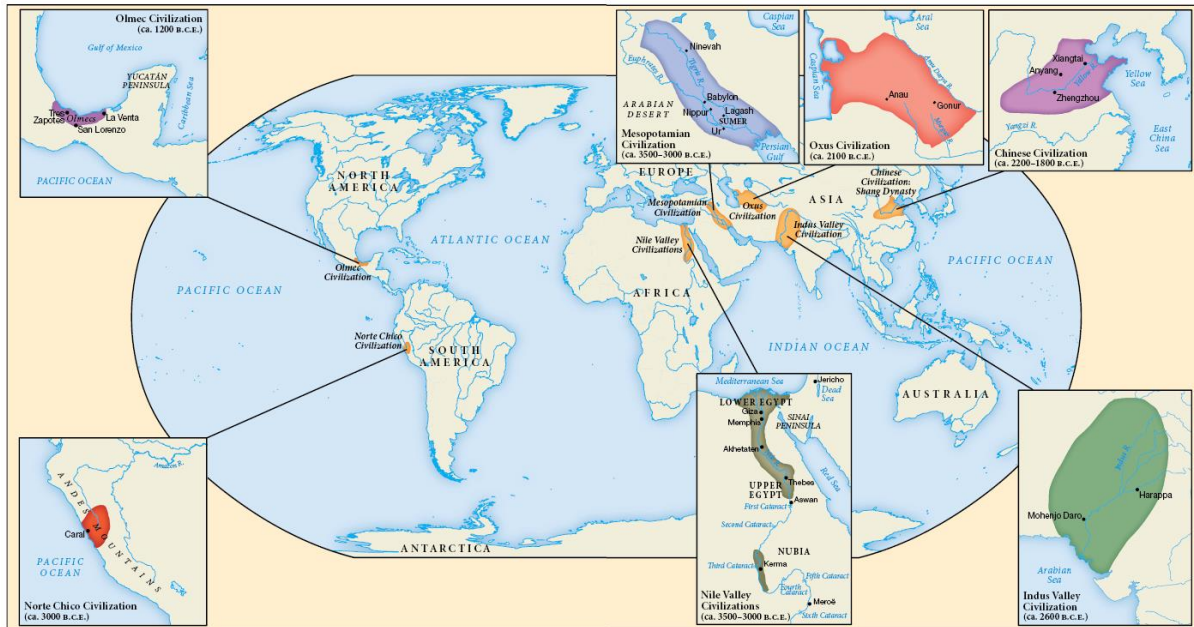

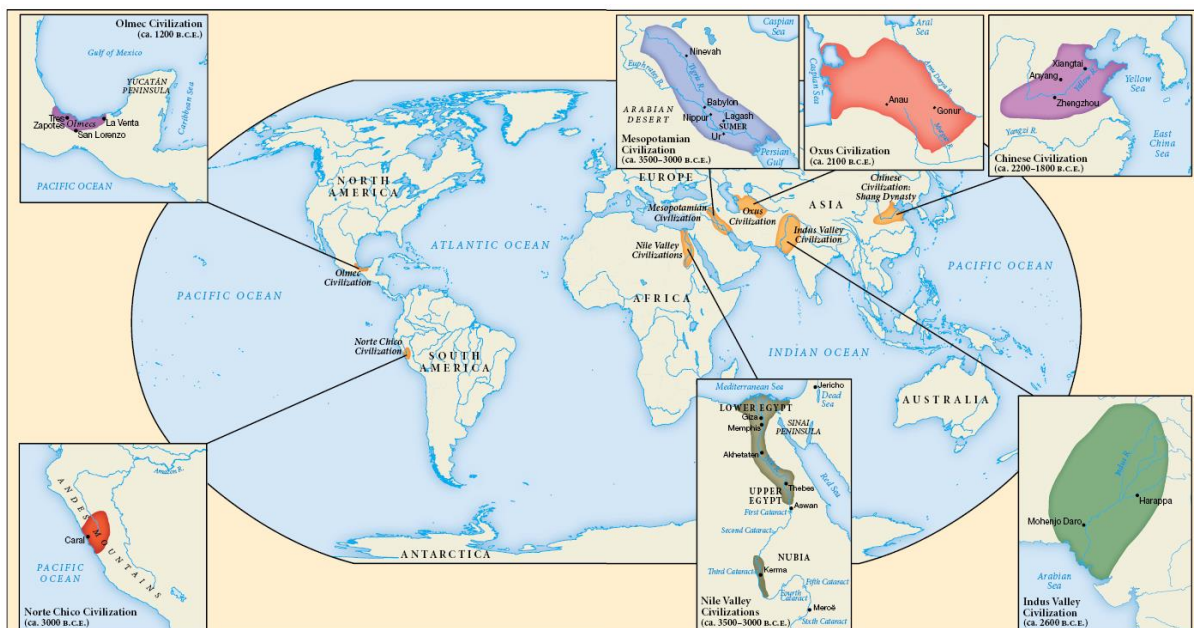

36. Identify the three earliest civilizations, their geographic locations, and their political organizations.

ANSWER: *Answer would ideally include the following:* Sumer emerged around 3500 B.C.E. to 3000 B.C.E. in the southern reaches of Mesopotamia (a region mostly in present-day Iraq). Sumer was composed of many competing city-states. Egypt emerged around the same time in the Nile River valley in northeastern Africa. Egypt viewed itself as a unified territorial state. Norte Chico developed from 3000 B.C.E. to 1800 B.C.E. along the central coast of Peru. There were twenty-five urban centers in the area known as Norte Chico.

37. Identify the different social classes in the First Civilizations, and give specific examples of people within each class.

ANSWER: *Answer would ideally include the following:* The upper classes consisted of the rulers and the royal family, nobles, and high-ranking officials. Free commoners consisted of artisans, lower-level officials, soldiers, police, servants, and farmers. Enslaved people consisted of prisoners of war, criminals, and debtors.

38. How did class differences create different roles and expectations for women?

ANSWER: *Answer would ideally include the following:* Upper-class women led privileged but restricted lives. They were limited to the home and managed servants and slaves. Lower-class women were always out in the public. They worked fields, tended livestock, bought and sold goods in the streets, and worked as servants in the homes of the upper class. A few women acted in masculine roles, while others pushed against limits and restrictions assigned to women.

39. Name at least three features typical of a king in one of the First Civilizations.

ANSWER: *Answer would ideally include the following:* Kings headed states, employed ranked officials, exercised a measure of control over society, and defended against external enemies. Kings also frequently claimed divinity or divine approval for their rule. Kings also lived a lavish lifestyle, arranged impressive rituals, and created monuments and structures. Their deaths were followed by elaborate burials.

40. Explain how religion or association with the divine in the First Civilizations could be used to both legitimize and restrain the authority of the state.

ANSWER: *Answer would ideally include the following:* Religion or divinity was used to legitimize state authority in many ways. Class and gender inequalities were ordained by the gods. In China, the emperor was portrayed as the Son of Heaven. In Mesopotamia, rulers were viewed as stewards of their city's patron gods. In Egypt, pharaohs were believed to have divine qualities and supernatural powers. Symbols of kingship were associated with the sacred. However, religion could also restrain state authority. Hammurabi's law code, intended to keep the strong from harming the weak, claimed

to be inspired by Marduk, the chief god of Babylon. The Mesopotamian monarch Urukagina invoked authority from the city's patron god to launch reforms to end the corruption and tyranny of the previous ruler. In China, emperors in Western Zhou could be overthrown if their bad behavior resulted in their loss of the Mandate of Heaven.

41. Identify the different purposes of writing in the First Civilizations.

ANSWER: Answer would ideally include the following: Literacy defined elite status and gave enormous prestige to those who had it. Writing could be used as propaganda to celebrate the deeds of kings. Writing served an accounting function to keep track of taxes, debts, and wages. Calendars indicated when certain rituals should be performed. Written orders, regulations, and laws gave more weight to state decrees. Writing also gave rise to literature, philosophy, astronomy, mathematics, and history. Finally, writing could be used to criticize the state and kings.

42. What new products and technology did Egypt's interaction with the outside world bring?

ANSWER: Answer would ideally include the following: Wheat and barley reached Egypt from Mesopotamia. Gourds, watermelon, domesticated donkeys, cattle, and the practice of "divine kingship" came from Sudan. From Asia, Egyptians adopted the horse-drawn chariot, new armor and weapons, new textile techniques, new musical instruments, and olive and pomegranate trees.

43. Explain how the civilizations of Mesopotamia and Egypt affected the environment.

ANSWER: Answer would ideally include the following: In Mesopotamia, the timber required for construction led to deforestation and soil erosion. Long-term intensive irrigation from a complex and artificial network of canals and dikes led to increasing salinization of the soil. These changes sharply decreased crop yields. In Egypt, irrigation was only used to regulate the natural flow of the Nile and thus avoided the problem of salty soils. The Nile's overall regular and gentle flooding resulted in fewer environmental changes in Egypt.

44. Discuss patriarchy in the First Civilizations, specifically its possible origins and how it shaped society.

ANSWER: Answer would ideally include the following: Patriarchy is a social system in which women are markedly subordinate to men in the family and in society generally. Patriarchy is not a natural state; it arose out of many circumstances and varies across time and geography. For most of human history, gathering and hunting societies demonstrated an egalitarian structure without rigid categories of rich or poor and without a sharp contrast between the domestic feminine sphere and the public masculine sphere. Plow-based agriculture, however, privileged larger bodies unburdened by pregnancy. As plow-based agriculture performed away from the home became the primary means of resource acquisition and, by extension, status, women were relegated to secondary tasks and secondary status. Within a patriarchal society, sons are preferred to daughters due to property rights and inheritance. Social class also impacted the experience of women in the First Civilizations. Upper-class women lived very comfortable yet restricted lives. By contrast, the vast majority of poor women always had to be out in public, working in the fields, tending livestock, buying and selling in the streets, or serving in the homes of their social superiors. Plow-based agriculture and private property created circumstances in which women's labor was devalued and their rights were restricted.

45. Compare and contrast the impact of outside contact upon Egyptian and Mesopotamian civilizations.

ANSWER: Answer would ideally include the following: Agricultural exchanges introduced wheat, barley,

gourds, watermelon, domesticated donkeys, and cattle. The cultural influences of religion, writing, gods, goddesses, and art varied in each civilization. Finally, military technologies, including chariots, bronze metallurgy, armor, bows, daggers, and swords, are key developments. Egypt was protected from outside contact by its geography while Mesopotamia was more vulnerable to invasion. This also led to more living in cities in Mesopotamia, as well as eventual invasion by the Assyrians and Babylonians. By contrast, Egypt endured without outside invasion for 3,000 years.

46. Compare and contrast life in the First Civilizations of Sumer, Egypt, Norte Chico, Indus Valley, China, Oxus, and Olmec.

ANSWER: Answer would ideally include the following: Civilizations were "a new and particular type of human society, made possible by the immense productivity of the Agricultural Revolution." The answer should compare and contrast the geographic location, economies, urban areas, and style of government of each civilization.

47. Discuss how the emergence of the First Civilizations was both a positive and negative development for humankind.

ANSWER: Answer would ideally include the following: In a civilization people share knowledge and technology. Due to the intense organization of people, status, and knowledge, some people are allowed more conveniences than others, and leisure, art, and entertainment emerge. Writing, monumental art, and literature made strides for humanity. Another positive aspect of civilization was increased productivity and the abundance of food and goods. Negative aspects of civilization included the institutionalization of social, economic, and gender inequality; large-scale warfare; and epidemic disease.
