Suggested answer: Sample response: The social exchange framework views interaction and choices in terms of cost and profit. It operates from a premise of utilitarianism. The family life course development framework emphasizes the important role transitions of individuals that occur in different periods of life and in different social contexts. The structure-function framework emphasizes how marriage and family contribute to society. Functionalists view the family as an institution with values, norms, and activities meant to provide stability for the larger society.

Review the elements of marriage discussed in the text. Do you think there are other elements of marriage aside from those discussed in the text?

Suggested answer: Sample response: Elements of marriage include legal contracts, emotional connection, sexual monogamy, legal responsibility for children, and public announcement. Marriage in the U.S. is a legal contract into which two people of different or the same sex and legal age may enter provided they are not already married to someone else. Emotional connection (love) is an important motive for getting married in the United States. Marital partners generally expect sexual monogamy, though some (5% to 20%) couples negotiate other arrangements involving consensual non-monogamy. One of the most important reasons for the existence of marriage from the viewpoint of society is to legally bind a couple for the nurturance and support of any children they may have or adopt. Public knowledge of the event helps to solidify the commitment of the partners to each other and helps to marshal social and economic support to launch the couple into married life.

Suggested answer: Sample response: The choice of whether to marry, whom to marry, when to marry, whether to have children, remain emotionally/sexually faithful, and to protect yourself from unwanted disease/pregnancy is important. Not making a decision is a decision. Action must follow a choice, and making a choice causes us to relinquish others. Some choices may require correction. Choices include selecting a negative or positive view. Some choices are revocable, while others, such as having children, are not. Using technology can be a positive or negative choice in relationships. Choices are influenced by your current stage in the family life cycle. There are global, cultural, and media influences on your choices.

How would you define “family”? Include a legal, sociological and cultural definition in your response, as well as a description of those referred to as your family.

Suggested answer: Sample response: The U.S. Census Bureau defines family as a group of two or more people related by blood, marriage, or adoption. Families are often defined by function rather than by structure. Sociologically, a family is defined as a kinship system of all relatives living together or recognized as a social unit, including adopted individuals. It is the basic social institution of society because of its important functions of procreation and socialization. Fictive kin (also known as families of choice, voluntary kin, discretionary kin and nonconventional kin), refers non-biological and non-legal relationships that are close, meaningful and supportive. Family of origin is the family into which you were born or the family in which you were reared. The family of procreation represents the family that you will begin should you marry and have children.
