Explain how in the crime control model, criminal justice is viewed as an “assembly line,” and in the due process model it is viewed as an “obstacle course.”

Suggested answer: Sample response: With the crime control model, the criminal justice system is viewed as a factory. The purpose of the system is to be swift and efficient in case processing. Therefore, this model often uses plea bargains because they most quickly result in the greatest amount of convictions. On the other hand, the due process model views it as an obstacle course. The criminal justice system consists of several legal challenges that must be satisfied to hold someone accountable for a criminal action. It is important to ensure that the system has done everything according to correct procedure.

Suggested answer: Sample response: For people who watch reality TV shows based on the criminal justice system, perceptions of crimes are based on the skewed presentation of high-profile cases, usually of unusual crimes or motives. People may think they know the law because they have watched these shows, but these shows are often inaccurate.

Discuss a potential ethical problem with discretion. Provide an example.

Suggested answer: Sample response: People working in criminal justice may have differing views on issues. For example, an officer who works in a state in which marijuana is not legal may not see smoking marijuana as a problem. Therefore, they do not arrest people on marijuana possession, even though it is illegal in their jurisdiction. They are letting their own views on what is right or wrong dictate the decisions they make on the job.

Suggested answer: Sample response: The bottom layer of the cake represents misdemeanors. Misdemeanors are the majority of cases that are handled by the criminal justice system, and they are the least serious types of crimes. That officer then realizes that the person driving the vehicle is his own brother. The officer will then have to decide if they will do the right thing in this situation.*
