Choose one example of a mental mistake discussed in the textbook. Explain the mental mistake and evaluate its effects on a criminal investigation.

Suggested answer: Sample response: One of the main mental mistakes committed by investigators is confirmation bias. Confirmation bias is the tendency to pay attention only to evidence that supports already-existing beliefs. This is a hindrance in criminal investigations because it stops the investigators from considering new theories, suspects, or directions the case may go. If investigators pursue a particular theory as a foregone conclusion rather than follow the evidence, it could lead to a serious miscarriage of justice.

Discuss the role of the criminal investigation process in the criminal justice system and evaluate its importance.

Suggested answer: Sample response: There are three components of the criminal justice system: police, courts, and corrections. All three parts of the criminal justice system work to reduce crime, but each also has its own specialized function. If one is not functioning properly, then the rest of the system cannot do its job. Criminal investigation occurs as one of the very first steps in the process, immediately after a crime is reported. As such, it is one of the most critical aspects of the criminal justice system. If a criminal investigation does not succeed, police cannot identify and apprehend perpetrators, the courts cannot adjudicate the accused, and corrections cannot punish the convicted.

Identify and discuss the three potential problems with evidence in criminal investigations. Which problem do you think poses the greatest risk to an investigation? Justify your choice.

Suggested answer: Sample response: Investigators may not know the relevance of the information at the time of collection or if it is even related to the case at hand. Also, the police may be overwhelmed with too much information that they cannot adequately collect, manage, and follow-up on every tip. Lastly, the evidence obtained may not be accurate, as with eyewitness identifications that are persuasive yet problematic. I think that the greatest risk to an investigation is that police may be overwhelmed by the number of investigations they are attending to. The other two potential problems with evidence can be overcome by police collecting additional evidence that brings these issues to light. However, if police do not have the time to adequately collect evidence in the first place, then the other potential issues with evidence will not be discovered.

Explain why law enforcement agencies do not solve more crimes than they do. What could be done to improve police success in this regard?

Suggested answer: Sample response: Despite the numerous reasons that crimes may go unsolved by law enforcement agencies, one of the largest is likely the underreporting of crimes, in general. For example, if you consider the crime of burglary, which has been discussed many times throughout the chapter, victims may be unwilling to report this crime. One such instance could be that they know the perpetrator and do not want to get them in trouble. Secondly, the nature and structure of the crime plays a role in the quality and quantity of evidence left behind at a crime scene. While many policies and trainings can help police increase the rate of crime solving (for example, a decrease in mental mistakes). Using proactive strategies, like undercover operations that may allow officers to infiltrate burglary networks.

You are the head of an investigative team and have been assigned to investigate a string of burglaries of electronics stores in an area. You have decided to pursue an undercover operation. Which strategy would you choose? Justify your choice and illustrate the process of this operation.

Suggested answer: Sample response: Since the crime being investigated involves a specific type of burglary (electronics), I would set up a decoy operation. I would attempt to work with a business owner in the community to create an opportunity for the burglars to commit the crime again, while secretly monitoring the location. This opportunity would most likely involve leaving an electronics business unlocked overnight while officers monitored it. Another option might be an undercover fencing operation, in which my team would pose as a business buying stolen goods. If we received a large amount of stolen electronics, we could trace the goods back to the burgled stores and thereby arrest the perpetrators.
