Suggested answer: Sample response: Ethical relativism, which includes cultural relativism, suggests that what is morally right or wrong may vary in a fundamental way from person to person or from culture to culture. Cultural relativism is a type of ethical relativism looking at variations in moral expectations depending on culture. In order to judge a person by ethical standards we must consider that person by the standards of their own culture and not by our own. Ethical absolutism on the other hand asserts that there is a universal and unchanging moral law that is the same for all people. There is only one true perspective as to what is right and wrong. These perspectives are essentially opposites in their assertions.

How does the theory of ethical pluralism help one steer a course between ethical relativism and ethical absolutism?

Suggested answer: Sample response: Ethical pluralism is the belief that in most situations there are no absolute single truths and instead there are many truths. Where ethical relativism and ethical absolutism seem to be at opposite ends of the spectrum, ethical pluralism allows for an approach that more of a middle ground between these two theories. While there are times where the majority agree on ethics there are other times where the culture will dictate the ethics. Ethical pluralism incorporates four principles into these decisions including the principle of understanding, the principle of tolerance, the principle of standing up against evil and the principle of fallibility. Applying these principles allows us to consider when ethics are more universal and absolute or when we need to consider the cultural context of the situation.

Explain how an officer would go about analyzing and solving an ethical dilemma. Use an example to illustrate.

Suggested answer: Sample response: In order to address an ethical dilemma an officer must identify the issue, gather information about the issue, identify options for how to proceed and then making a final decision on how to handle this dilemma after applying the ethical approaches to each course of action. An example of this would be an officer who pulls over a driver who is driving erratically. When he approaches the car he realizes that the driver is a fellow officer. He recognizes that this is an ethical dilemma. His department has informed officers that they should extend "professional courtesy" to each other for certain infractions. The officer begins to assess the situation and recognizes that the fellow officer is under the influence. He considers his options. If he lets the fellow officer off without consequence there is a risk that the officer will hurt himself or others on his way home. If he takes him into custody, he could be reprimanded for not following protocol about professional courtesy. A third approach would be to drive the officer home so he is safe and not report the incident. After considering each of these possible actions the officer decides that he should take the officer into custody. As an officer of the law, he must uphold the ethical standards expected of him and he feels that the fellow officer should be held accountable for his actions.

Why is the study of ethics an important part of the criminal justice field?

Suggested answer: Sample response: Ethics is an essential part of ensuring the criminal justice system is effective and just. The criminal justice system involves professionals who make discretionary decisions in their daily activities. These same professionals exercise power and authority over others and are able to use force. Both the law and accepted standards of behavior imposes ethical rules and responsibilities on these professionals. These professionals must understand and abide by ethical standards in carrying out these duties. Within criminal justice, ethics is crucial in decisions involving discretion, force, and due process because criminal justice professionals can be tempted to abuse their powers. Additionally, we must ensure that policies and practices are equitable and fair for all citizens.
