Rationale: Some components of specialty dental and large animal acrylic repair kits are also flammable. Very small amounts of these components can usually be safely stored in an area with good ventilation, free from flames or sparks. Schedule 1 drugs are not found in clinics as they are viewed to have no medical application. Laboratory equipment is generally safe, though it can catch fire if the surrounding area is engulfed. Fleece bedding used for cages is non-flammable.

Q2: Long hair should be tied back while at work for what reason?

- A. To prevent getting feces and urine in it
- B. To prevent dogs from licking it
- C. To keep from scaring cats
- D. To prevent entanglement in fans or dryers (Correct)**

Rationale: Long hair should be tied back to prevent it from getting caught in fans or other moving objects. While it is unpleasant to get urine or feces in your hair, this is not the primary reason. Dogs will lick whatever they can reach, and long hair doesn't scare cats.

Q3: If an unsafe condition is found at work, who should this be reported to?

Rationale: If you become aware of an unsafe condition, report it to your supervisor immediately. The police do not have authority to ensure hospital safety, though OSHA violations can be reported to the local OSHA inspector. It is everyone's responsibility to ensure safety at the hospital.

Q4: When handling stray, wild, or unvaccinated animals, OSHA recommends what safety equipment?

Rationale: OSHA recommends wearing examination gloves and a surgical mask when handling stray, wild, or unvaccinated animals. Tyvek equipment and full-face masks would be more useful

Rationale: More detailed information about every chemical can be found in the SDS filing system. SDS documents provide information that is vital for safe use in the hospital. Yellow pages are just business listings, and while Wikipedia may have information on specific chemicals, they are not SDS sheets, and OSHA will not accept this method of knowledge access. DEA is concerned with drug use and abuse, not chemical exposure.

Q6: What PPE is recommended when working in the kennel with barking dogs?

Rationale: PPE for exposure to loud noises, such as barking dogs, ear plugs are recommended. Safety glasses are used for preventing bacterial exposure to the eyes, a dosimetry badge measures exposure to ionizing radiation, and an N95 mask is used for surgery or aerosolized exposure.

Q7: When performing a medicated bath, what hazards are of concern?

There should be no means for you to become entangled in anything during a bath.

sides, including the top, you cannot prevent wild animals from entering your yard, and eradication of the wild reservoirs of raccoons, skunks, and bats is not feasible.

Q13: When taking radiographs, when is it okay for your hand to be in the primary beam?

Rationale: When using radiographic equipment, team members should never place any part of their bodies in the primary beam, even a hand wearing a lead-lined glove.

Rationale: Always use the collimator to restrict the primary beam to an area smaller than the size of the cassette, creating a clear border around all four sides of the film. The bright white image is likely poorly penetrated and is not diagnostic. If the black extends to the edge of the radiograph has not been correctly collimated, and sparkles are not a feature of radiographs.

Q15: When using a portable x-ray machine, what PPE is required?

Rationale: When using a portable machine, you must always be sure that there is no human body part in the path of the primary beam, even at a distance. Never hold a cassette during the radiographic procedure, whether wearing lead-lined gloves or not; always use a cassette-holding device. Also, wear a lead-lined apron, thyroid collar, and gloves.

Q16: Exposure to halogenated gases in the surgical suite can contribute to what problem?

Rationale: Long-term exposure to waste anesthetic gases (WAGs) has been linked to congenital abnormalities in children, spontaneous abortions, and liver and kidney damage. OSHA has set the safe exposure limit for halogenated anesthetic agents (e.g., isoflurane or sevoflurane) at 2 parts per million (ppm). According to some sources, as much as 90% of the anesthetic gas levels found in

the surgery room during a procedure can be attributed to leaks in anesthesia machines.

Q17: What action can decrease the exposure to waste anesthetic gas?

Rationale: As much as 90% of the anesthetic gas levels found in the surgery room during a procedure can be attributed to leaks in anesthesia machines. Therefore, you should always check for leaks in the hoses and anesthesia machine before use. A full-face mask will not prevent the inhalation of anesthetic gases, nor will an N95 surgical mask. It is not recommended to have open doors or windows in the surgical suite to prevent recovering animals from escaping and to prevent unknown windborne contaminants from blowing into the room.

Q18: What is a scavenging system designed to do?

Rationale: A well-designed scavenging system captures excess gases directly at the source and transports them to a safe exhaust port, usually outside the building. This is the most effective means of reducing exposure to waste anesthetic gases in the workplace. A dehumidifier would be used to decrease indoor humidity, to mitigate noise in the kennels, ear protection is used, and disinfection is used to decrease pathogen exposure.

Q19: What is the function of soda lime granules in anesthesia?

- A. Absorbs carbon dioxide (Correct)**
- B. Inactivates WAGs
- C. Decreases anesthetic time
- D. Helps maintain body temperature

Rationale: Soda lime granules absorb and trap carbon dioxide into gas exhaled in anesthesia machines. WAGs cannot be deactivated but must be scavenged from the room. As soda lime granules are outside of the anesthetic circuit, it has no effect on anesthetic time, or body temperature.

Q20: What does a dosimetry badge measure?

- A. Sterilization of surgical packs

Rationale: A dosimetry badge measures your exposure to scatter radiation produced when taking radiographs. Sterility indicators are used to ensure surgical packs are sterilized, and vaccination status would need to be tested by doing titer tests.
