Asian American families are often seen as being very child-centric. Explain what this means and how it impacts these families.

Suggested answer: Sample response: Within the Asian American family structure, a greater emphasis is placed on the parent–child relationship than on the husband–wife relationship. In exchange for the undivided loyalty and for sacrifices parents make for their children, Asian American parents expect respect and obedience from their children.

Describe how the microsystem and macrosystem, in Bronfenbrenner's Ecological Model, are related.

Suggested answer: Sample response: The microsystem and macrosystem are related in that the macrosystem encompasses the broader cultural, social, and economic contexts that influence and shape the environments within the microsystem. The microsystem includes the immediate settings and interactions an individual experiences, such as family, school, and peers, while the macrosystem represents the overarching societal patterns, values, laws, and customs that indirectly impact an individual's development by affecting the various elements within the microsystem.

Suggested answer: Sample response: First-generation immigrant children were born outside of the United States, whereas second-generation immigrant children were born in the United States to immigrant parents.

Suggested answer: Sample response: Today in the United States, there is more familial diversity than ever before. Contemporary American families are complex and diverse, ranging from traditional two-biological-parent family structures to single-parent homes, to extended family forms, to married gay or lesbian couples. There is also greater diversity of racial, ethnic, economic, and religious composition.

Suggested answer: Sample response: Polygyny is the practice of a man having multiple wives at the same time while polyandry is the practice of a woman having multiple husbands at the same time.

Q49. [Essay]

What does the term “family values” refer to?

Suggested answer: Sample response: The term most often refers to a society's paradigm or viewpoint that expects its members to adhere to perceived proper social roles, such as marrying and having children, remaining monogamous and faithful to the marriage partner, and opposing same-sex relationships, marriages, and parenting by gay or lesbian partners. The family values viewpoint also frowns on births to women outside of marriage. It evokes a certain set of ascribed gender roles; for example, the women fulfill homemaker and mothering responsibilities (the bread maker role), and the men fulfill the role of primary wage earner (the breadwinner role). This family form is also considered a patriarchy, wherein the male is dominant and oversees most decision-making in the family.
