If the variables influence stakeholders to pursue policy that is for individual interests, it is an inhibitor.

Problem analysis can occur when a problem—by definition—exists, and consists of reviewing the situation—also known as the desire—and all possible solutions—also known as the outcomes and consequences. This analysis leads to a determination of whether the problem can be resolved with a policy.
