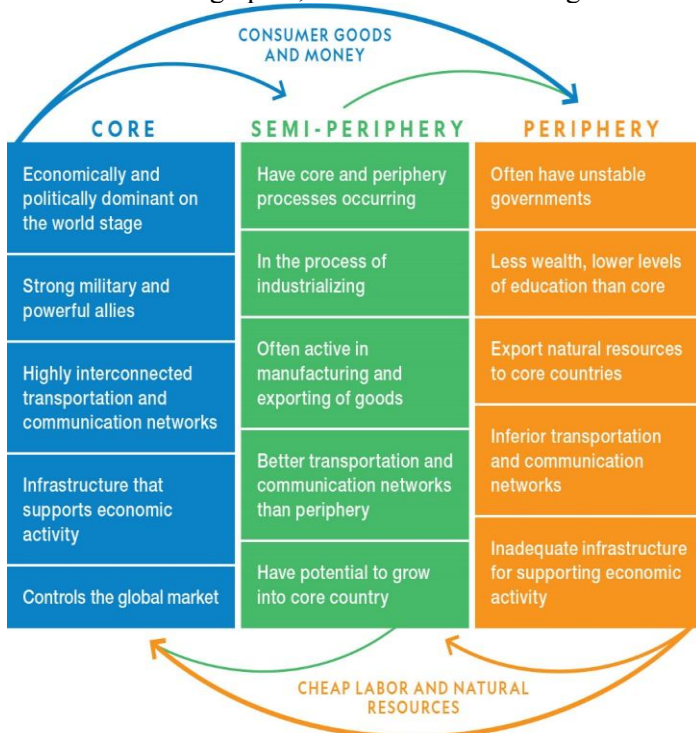

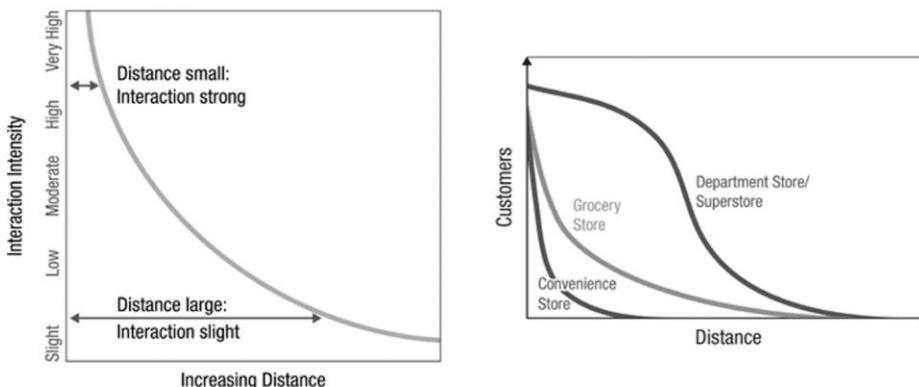

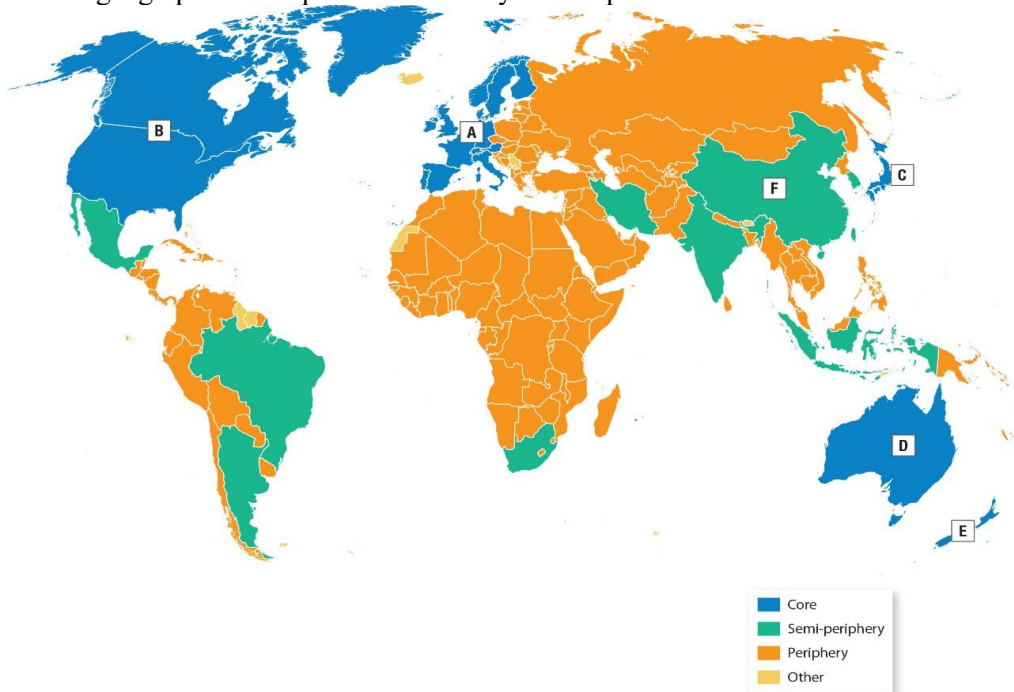

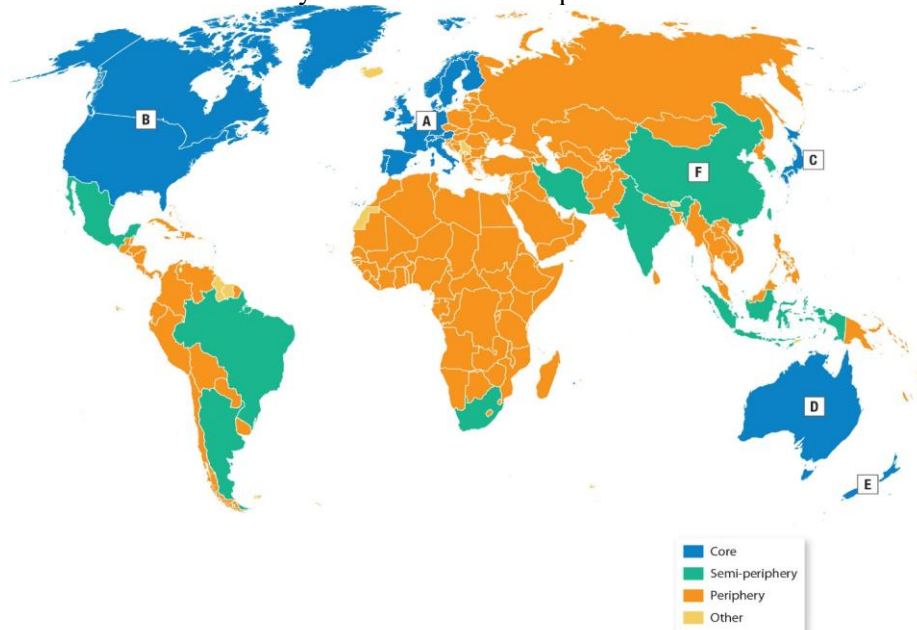

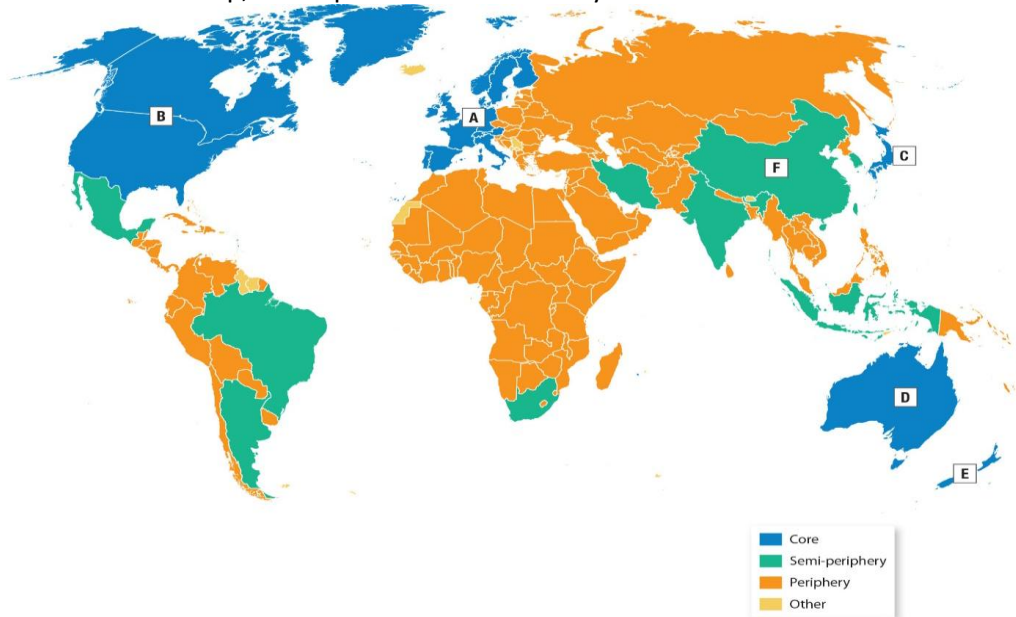

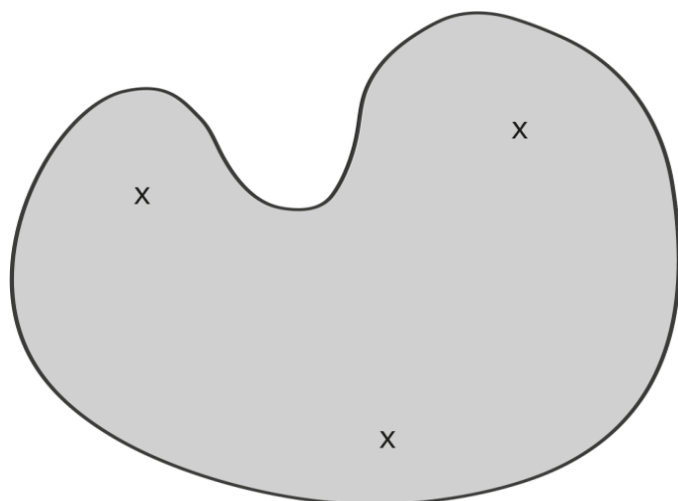

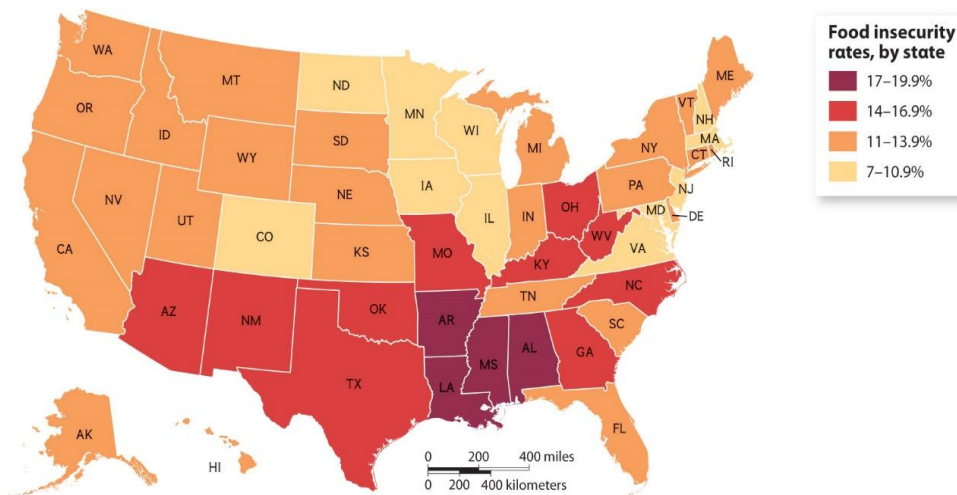

66. Explain how geographers use both the spatial and ecological perspectives to interpret and explain spatial processes on Earth.

ANSWER: Responses will vary but should demonstrate an understanding of the definition of spatial perspectives as referring to where something occurs, and of ecological perspectives as referring to the relationships between living things and their environments.

67. Use a specific example to define *absolute location* and *relative location*, and explain the usefulness of each.

ANSWER: Responses will vary but should differentiate between absolute location as a description of an exact location, and relative location as a description of where a place is in relation to other places or features. Absolute place may include the coordinates of longitude and latitude, while relative location is a description of places in relation to other places. Students should note also the relative usefulness of these two types of location; for instance, absolute location is useful because it means the same thing to everyone, while relative location can take advantage of a group's common knowledge of the location of other places.

68. Identify three physical and three human characteristics of a particular place, and explain how they all contribute to the character of the place.

ANSWER: Responses should include three physical characteristics (climate, landforms, soil, water sources, vegetation, or animal life) and three human characteristics (language, religion, political system, economic system, population distribution, architecture, or quality of life). In their combinations, they contribute to the character of, say, an industrial manufacturing (human factor) town at the mouth of a river (physical factor), or a sprawled community of farms (human factor) in the irrigated (human factor) fertile central valley (physical factor).

69. Compare the concepts of site and situation.

ANSWER: Responses will vary but should demonstrate an understanding of the difference between site (a place's

absolute location and physical characteristics) and situation (a place's location in relation to other places or its surrounding features, connections to other places, political associations, and economic and cultural ties).

70. Explain what geographers mean by flow, and why the concept is an essential area of geographic study.

ANSWER: Responses should demonstrate an understanding of the term flow as it is used in geography. Students should note that flow helps geographers understand the movement of people, goods, and information as well as the impact of these movements on societies.

71. Use a specific example to define a formal region on the basis of physical characteristics and distinguish it from nearby regions.

ANSWER: Responses will vary, but students should provide a specific example of a formal region that is defined according to a landform, climate area, or other physical characteristics.

72. Use a specific example to explain how one place can belong to multiple regions and what that variety of regions says about the character of the place.

ANSWER: Responses will vary, but the examples should illustrate an understanding of how one place can belong to multiple regions, largely because the boundaries between regions are not clearly defined and are often transitional or overlapping. The example provided in the book is the U.S. Southwest, which is thought of as one distinct region, and El Norte in Mexico, which is considered to be its own region, though both areas can also be considered a single region. There are many other examples that might be included, particularly if students include formal regions (such as New England) versus perceptual regions (the East Coast).

73. Use a specific example to define a formal region on the basis of human characteristics, and distinguish it from nearby regions.

ANSWER: Responses will vary, but students should note a specific example of a formal region that is defined on the basis of human characteristics such as language or religion.

74. Explain the role of the node in a specific functional region.

ANSWER: The node is the focal point of a functional region, such as the downtown of a city or the hub of a transportation network.

75. Compare the clarity of the boundaries of formal and perceptual regions using specific examples of each.

ANSWER: Responses will vary but should demonstrate an understanding that the boundaries of formal regions are clearer than those of perceptual regions. Thus, while the nations of the Eastern Bloc under the Warsaw Pact during the Cold War constituted a formal region, today's Eastern Europe is a perceptual region that depends on people's ideas of where Europe ends and Asia begins. Similarly, the American South today is a perceptual region which may or may not include states like Maryland, Texas, Arizona, or Kentucky. During the Civil War, "the South" was a formal political region organized in rebellion against the United States.

76. Explain how Wallerstein's description of the world as one entity with a single market and labor force reflects the rise of globalization.

ANSWER: Wallerstein's world system theory describes the world as one entity with a single market and labor force. This demonstrates the rise of globalization, which has contributed to the interconnectedness of countries around the world and the businesses within them.

77. Compare core-periphery terminology to the terms developed country and developing country.

ANSWER: The terms developed and developing were used to describe countries beginning in the 1950s, but critics believe that they incorrectly assume that these countries want or need to "catch up" with Western ideals. The

terms core, semi-peripheral, and peripheral are used instead to describe countries at different levels of the world hierarchy.

78. Identify two features of peripheral countries.

ANSWER: Possible responses include having less wealth, lower education levels, less sophisticated education, less stable government, poorer services such as health care, inferior transportation networks or infrastructure, inferior connections within and beyond the country, and less ability to support economic activity.

79. Explain the degree to which Wallerstein's theory focuses on economics and does not address other human activities.

ANSWER: Responses will vary but should demonstrate an understanding that the world system theory focuses on the economic relationships among countries, particularly the exploitation of peripheral countries by core countries. A criticism or limitation of the theory is that it does not consider political or social relationships.

80. Explain how semi-peripheral countries differ from both core and peripheral countries.

ANSWER: Semi-peripheral countries are in the process of industrializing and may be active in the manufacturing and exporting of goods. They have better connections than peripheral countries, but they are not as strong or "advanced" as core countries.

81. Identify one country in each of Wallerstein's categories and explain why each is so classified.

ANSWER: Responses will vary, but students should identify one core country, one semi-periphery country, and one periphery country, as shown in the "World System Theory" map. Responses should further identify the core country as being at the top of the hierarchy (economically and politically dominant); the periphery country being at the bottom (with less wealth and inadequate infrastructure to support economic activity); and the semi-periphery being between the two (with both core and periphery processes occurring).

82. Explain what factors limit peripheral countries from advancing in the hierarchy of Wallerstein's rankings.

ANSWER: Responses will vary but should include an understanding of the limitations and challenges that may prohibit peripheral countries from advancing in the hierarchy. These may include any of the problems identified in Task (C), or focus on the exploitation of peripheral countries by semi-peripheral and core countries.

83. Compare the scales of the two maps of New Orleans.
