In your view, is criminology a science? State your viewpoint and defend that perspective.

Suggested answer: Sample response: In my view, criminology can be considered a science as it has evolved from sociology and engages in processes to advance our understandings of criminal behavior. Criminology is generally defined as the science or discipline that studies crime and criminal behavior. Specifically, the field of criminology concentrates on forms of criminal behavior, the causes of crime, the definition of criminality, and the societal reaction to criminal activity; related areas of inquiry may include juvenile delinquency and victimology (the study of victims). While there is considerable overlap between criminology and criminal justice, criminology shows a greater interest in the causal explanations of crime, whereas criminal justice is more occupied with practical, applied concerns, such as technical aspects of policing and corrections.

Q52. [Essay]

What are Comte's three stages of knowledge, and why has modern criminology settled on the third perspective?

Suggested answer: Sample response: The three stages of knowledge according to Comte are theological, metaphysical, and scientific. Theological views of the world state that everything related to the world exists as it does because God has set it up that way. This evolved into metaphysical views of knowledge, which questioned this perspective and attempted to establish logic and reasoning as the ways to figure out how the world works. Finally, the third stage of knowledge is the scientific viewpoint. This is the most widely adopted and particularly important because it encourages the advancement of knowledge and the empirical testing of hypotheses to determine why the world works the way that it does.

Describe the relationship between the law and informal methods of social control in our modern society.

Suggested answer: Sample response: Laws represent formal modes of control, codified rules of behavior. If one accepts the consensus model of law, laws represent an institutionalized view of what is acceptable behavior. Informally, society controls the actions of individuals through acceptance or lack thereof, whereas laws are enforced predominantly by formal agents of social control such as police officers. This is commonly done by members of society not accepting others when they violate folkways. This shows that there are really multiple methods of social control, and we are not solely controlled by government agents (formal) but also controlled by informal mechanisms.

What is the key difference between acts that are considered *mala prohibita* and *mala in se*? Which type of act do you think that the government spends most of its energy on?

Suggested answer: Sample response: Acts that are defined as *mala prohibita* refer to those that are "bad because they have been prohibited." That is, such acts are not viewed as bad in themselves but are violations because the law defines them as such. Traffic violations, gambling, and infractions of various municipal ordinances might serve as examples. On the other hand, *mala in se* acts are those that society considers to be wrong in and of themselves. I believe that the government spends a bit too much time on *mala prohibita* crimes (such as smoking marijuana or speeding) and less on crimes that people most care about – especially if the cases are difficult – such as rape or murder, crimes that are *mala in se*.

In your own words, what were Émile Durkheim's ideas concerning social change and crime? Do you agree with his perspective?

Suggested answer: Sample response: Durkheim believed that crime was actually a normal factor of society. No matter what a society tried to do, there would always be at least some level of crime in society. Not only that, it was a beneficial thing for society because it allowed non-law-breaking society members to bond together in their distaste and punishment of law-breaking behavior. I agree with this perspective, because I think that whenever somebody breaks a rule, and other people know it, the other people typically come together to denounce the person who has broken such a rule.

Of the three models of the origin of criminal law – conflict, consensus, and interactionist – which do you think is the most accurate in describing how laws are created?

Suggested answer: Sample response: I believe that the most accurate way to describe the creation of laws is viewing them through the consensus perspective. Except in some cases (such as marijuana legalization), people generally consider laws to reflect their values and the values of society. We may not like a speed limit being so low, but we understand that it is there for a reason. Further, I think laws often change in line with people's views through protest and legislation, continuing the idea of consensus about what laws should exist.

Identify the criteria that must be met in US criminal law for an act to be considered a crime.

Suggested answer: Sample response: There are several criteria for something to be considered a crime. First, the act must be prohibited by law and contain legally prescribed punishments. Second, a criminal act must have taken place. Third, social harm of a conscious, voluntary nature is required, meaning there must be injury to the state or to people. Finally, the act is performed intentionally, although cases of negligence and omission may be exceptions, and the voluntary misconduct must be causally related to the harm, meaning it must be shown that the decision or act directly or indirectly caused harm.

In a criminological/sociological study, what are some of the limitations to defining “crime” as only those actions in violation of criminal law? Do you feel that criminologists should limit their study in this manner?

Suggested answer: Sample response: Defining crime as strictly violating criminal law would relegate the field of criminology to a position as status quo handmaiden of political systems. Hitler's genocide or Stalin's purges were accepted conduct within their political ideological systems. Criminologists must study the deviants—the people who commit crime—as well as the social structural contexts that define them. To provide additional perspectives on crime, it is sometimes viewed in ways other than those suggested by the standard legal definitions. Such alternatives define crime in terms of the type of victim (child abuse), the type of offender (white collar crime), the object of the crime (property crime), or the method of criminal activity (organized crime). Such definitions usually cover one or more of the standard legal definitions.

Why is it so important to think beyond simply the economic consequences of crime when considering the impact crime has on our society?

Suggested answer: Sample response: Crime certainly has a major impact on our society in economic terms – where money or goods are directly taken in illegal ways that hurt people in monetary terms. However, thinking of crime solely as an economic issue would ignore the social and psychological costs that criminal activity has on victims, particularly in terms of fear and mistrust. We must be aware of criminal behavior's impact in a variety of ways to fully understand the consequences of such behavior in a holistic way.

Provide an example of a folkway in contemporary society, and argue as to why this should be considered a folkway instead of a more or law.

Suggested answer: Sample response: Folkways are informal norms that people follow because it is generally accepted behavior in society. Therefore, an example would be not putting your elbows on the table while eating. Generally, mores and laws are looked down upon by members of society more than folkways are, with laws actually being codified and sanctioned by the government for breaking them. Therefore, putting your elbows on the table is a good example of a folkway, rather than something that aligns with more distaste from society like a more or law.

Q76. [Essay]

Provide an example of an act that is considered *mala in se*. Why is this act considered this way?

Suggested answer: Sample response: Rape would be considered an act that is *mala in se*. Acts that are *mala in se* are "acts bad in themselves," forbidden behaviors for which there is a wide-scale consensus on the mores for prohibition. The universality of laws against murder, rape, assault, and the like, irrespective of political or economic systems, shows that many cultures harbor similar levels of distaste and discouragement of these types of acts. Rape is a major violation of another human being, and has severe sanctions in American society, showing that this is considered a major violation of human rights.

Q77. [Essay]

Describe the difference between overcriminalization and undercriminalization. Provide an example of each.

Suggested answer: Sample response: Overcriminalization describes an overextension of criminal law to penalize acts that are inappropriately or not responsibly enforced by such measures. Oftentimes these acts are against a certain type of people as well (such as a member of a minority community or a person with low socioeconomic status). An example would be overpolicing of minor drug infractions. On the other hand, undercriminalization refers to the fact that the criminal law fails to prohibit acts that many feel should be criminalized. An example of this could be price-fixing in the corporate sphere that raises prices for the average American on necessary goods.

Q78. [Essay]

Define latent and manifest functions, and give an example of a manifest function and a latent function of a law of your choice.

Suggested answer: Sample response: Manifest functions are those that are intended consequences of a certain action. Latent functions, on the other hand, refer to the unintended consequences – both good and bad. For example, a local community might have a law that requires citizens to not play loud music after ten P.M. A manifest function of that would be to have the community be quieter (the intended consequence) but a latent consequence might be that bars and restaurants close earlier for fear of receiving a fine, and there are fewer places for community members to meet up later at night (an unintended, negative consequence).

Q79. [Essay]

Give an example of a criminal action where a suspect would not be found guilty because they did not have *mens rea*.

Suggested answer: Sample response: *Mens rea* refers to a "guilty mind" of a suspect, which is essentially where a person knowingly and willingly violates a criminal statute. People who are diagnosed with insanity or a history of mental disturbance often do not possess the ability to make such meaningful violations, and then could be found not guilty of the crime. An example would be a person who convinced the jury that he committed murder because a neighbor's dog told him to. This person would be considered to have a mental disturbance and thus not capable of having *mens rea*.

What is the difference between a misdemeanor and a felony? Please provide an example of both.

Suggested answer: Sample response: A misdemeanor is typically a less serious offense punished by less than a year in jail. An example of this could be stealing a granola bar from a grocery store. On the other hand, felonies are typically more serious, and require people to spend significantly more time in prison. A felony would be something like armed robbery of a grocery store, where an individual uses a gun to take thousands of dollars from the cashiers.
