1. The state legislature passes a law, known as the Nurse Practice Act.
2. Regulatory bodies, such as the state nursing board, then create and implement rules and regulations intended to protect the public.

Sample Answer: Key points include the following.

- Each team member in each location must have the ability to work cohesively and in tandem, creating a streamlined workflow of communication and delivery of care.
- To ensure that they can do this, the team should rely on telehealth to enable them to communicate and have regular meetings, coordinating and streamlining the collaborative patient care process to ensure they provide efficient and effective patient care.
- They also should use electronic health records, which will allow each team member to read the notes of other healthcare professionals, avoid duplication, and better implement the patient care plan, as well as avoid potential adverse events like prescribing incompatible medications.

Sample Answer: These factors are called social determinants of health (SDOH). They include environmental and other factors that shape daily life, including access to healthcare and education, economic stability, community development, social and society norms, education, and political systems. SDOH can result in health disparities and inequities. To overcome SDOH and provide better healthcare, public health organizations should partner with education, transportation, and housing sectors to improve underserved residential communities.

Sample Answer: Key points include the following:

- The goal of primary prevention is to prevent disease before it occurs by making lifestyle changes to correct unhealthy choices or unsafe behaviors, preventing exposure to environmental hazards, and taking measures to increase resistance to disease or injury.
- The goal of secondary prevention is to promote early diagnosis and treatment to slow the progression of a disease or injury and reduce its long-term impacts. This process begins with early detection.
- The goal of tertiary prevention is to decrease the impact of an ongoing illness or injury. Effective tertiary treatment can help patients regain mobility and bodily function and maintain a positive quality of life.

Sample Answer: In systems-based practice (SBP), a clinician considers the multiple systems that are involved in a patient's condition and uses evidence about their interactions to develop a treatment plan that incorporates the intricacies involved in the patient's care. The layers of the healthcare system recognized by SBP include consumers of care, delivery systems such as hospitals and physician networks, insurers of care, providers of care such as nurses, and purchasers of care including individuals and governments.

37. What is patient-centered care? As part of your answer, explain the purpose of PCC and list several ways that nurses can practice PCC in nursing.

Sample Answer: Key points include the following information. PCC involves the following:

- requires listening to patients to understand what they value most, then using the information as the catalyst for healthcare decisions
- encourages the patient and family to be a part of the healthcare team, actively collaborating in the decisions that will formulate a customized plan of care and guide treatment decisions for the patient
- ensures the patient's needs and concerns are at the center of healthcare decisions and treatment plans
- ensures the organization's mission and values are driven by patient-centered goals

- equally values the patient's emotional well-being and physical comfort, incorporating the patient's emotional, mental, spiritual, social, and financial perspectives into their care

- promotes sharing information in a timely manner so the patient and their family can make well-informed decisions
- invites family members to become part of the care team by participating during rounds or shift changes
- knows what is most important to the patient and honors their directives

38. Define critical thinking and clinical judgment and explain how the two concepts are related. Then, describe how you would use critical thinking and clinical judgment to care for a patient with the following data:

- The patient is 42 years old and came to the hospital with a broken arm. They also have bruises on their face and shoulders.
- The patient lives with their spouse and a teenaged son. The police have visited the patient's home several times when neighbors complained about screaming and yelling.
- The patient's religious background prohibits them from accepting certain medical treatments.
- The patient is alone but will not make eye contact and mumbles answers.

Sample Answer: Key points include the following.

- Critical thinking is a multidimensional, systematic, and organized way of reasoning that involves purposeful, outcome-directed thinking. Critical thinking skills develop over time as foundational knowledge and key concepts combined with nursing experience and require mindfulness, effort, practice, and experience. Critical thinking enables the nurse to draw conclusions that lead to creative and appropriate decisions that promote effective solutions and positive outcomes.
- Clinical judgment is used to make decisions about patient care based on observations, assessments, and interpretations of relevant information that go beyond the application of technical skills and involves the integration of both empirical knowledge and practical wisdom.
- When critical thinking and clinical judgment are used together, this is known as clinical decision-making. Critical thinking enables nurses to sift through all the data and make evidence-backed decisions. Clinical judgment is the synthesis of the information, and clinical decision-making is the result.

- For the patient in this scenario, the components of critical thinking that apply include asking questions, gathering information, validating and analyzing information, maintaining a flexible attitude, and considering available options. Drawing on past clinical experiences with patients who have similar symptoms and circumstances will help with using clinical judgment to formulate decisions.

39. Use examples to explain the concept of an ethical dilemma. As a nurse, how can you recognize an ethical dilemma and what steps can you take to avoid ethical dilemmas?

Sample Answer: Key points include the following.

- Examples of common causes of ethical dilemmas in nursing include assignments that are contradictory to personal, cultural, or religious beliefs or to the Code of Ethics for Nurses; burnout associated with unsafe practices; complicated family dynamics of patients; dishonesty of peers; hostile work environments; life and death decisions that must be made; patients who refuse treatment; and short staffing or staff who fail to meet their responsibilities.
- The best way to recognize an ethical dilemma is to take notice of how a situation causes you to think and feel. You may feel pulled in two directions as you consider two courses of action. Neither course of action may be clearly incorrect; instead, each may emphasize different principles and values. You may feel that you have to choose between right and wrong or that either choice could have negative consequences.
- Your facility should have resources to help you make your decision.
- Avoiding ethical dilemmas is impossible.
- Since it is impossible to avoid ethical dilemmas, nurses must equip themselves with knowledge and resources to face these dilemmas. The most important thing is to deal with each situation in a professional manner that promotes quality care and patient safety.

- The purpose of research in nursing is to evaluate current knowledge and theories to formulate better nursing practices for improved patient outcomes.
- The purpose of EBP in nursing is to use the evidence from research to make informed decisions regarding patient care and outcomes. EBP is vital to providing the highest quality of patient care and safety.
- Qualitative research focuses on personal experiences obtained through observation and interaction with patients.
- Quantitative research uses deduction and generalization from empirical evidence to draw conclusions. Objective data gathered by the senses from observations or experiments are known as empirical evidence. These data are generally depicted by numbers in charts and tables for statistical purposes. Examples include identifying percentages, averages, and the mean of data.
- The five phases of nursing research include the conceptual, design and planning, empirical, analytic, and dissemination phase.
 - The conceptual phase in nursing research involves the identification and development of research ideas, hypotheses, and theoretical frameworks. It sets the foundation for the entire research process.
 - The design and planning phase focuses on brainstorming and determining which research method is most appropriate for the study.
 - Data are collected during the empirical phase.
 - During the analytic phase, researchers analyze the data to discern and validate relevant patterns and relationships in the data. Then researchers determine how the study's findings can best be used in clinical practice.
 - In dissemination, the researchers communicate their findings so others can use the information in their clinical practice. This phase also allows other researchers to try to replicate the study to see if they obtain similar results.
- Generally, the seven steps of EBP include encouraging a spirit of inquiry or curiosity, asking questions, searching for evidence, appraising the evidence, integrating the evidence into practice, evaluating outcomes of the practice change, and sharing the results.

41. What is the assumption of systems-based practice as it regards patients and how does this impact the quality of patient care? Provide at least two examples of SBP in healthcare. How can nurses be change agents in SBP? Finally, how do interdisciplinary teams function in SBP?
Sample Answer: Key points include the following.

- SBP assumes that each patient exists in a context of interconnecting, interdependent systems. These systems may be large or small, complex or relatively simple.

- The ability to recognize each system and understand how they work together and fit into the overall structure is essential to promoting the quality of patient care while also reducing errors.
- Examples of SBP in healthcare include approaching identified problems with the goal of solving them versus relying on a workaround; developing insight into the legal, political, regulatory, and economic factors that influence the delivery of healthcare; having an understanding of cost containment, resource allocation, patient advocacy, and interdisciplinary collaboration in the delivery of quality care; recognizing the outcome of individual and group actions as it affects quality care and patient safety; understanding how each different care setting works together for patients; and working in interdisciplinary teams to improve patient outcomes.
- As frontline care providers, nurses can effect change because they observe firsthand the impacts of various systems on delivering patient care. These observations can be used to bring about changes to improve patient safety and quality care, which are the goals of SBP.
- Effective teamwork is essential to developing competence in SBP. Bringing together team members with specialized skills and training from a variety of disciplines improves both the delivery of care and the outcomes for each patient. By implementing interdisciplinary patient rounds, team members can brainstorm solutions to identified problems and coordinate their implementation.
