Sociologists need both levels to understand how individual experiences are shaped by social structures, and how those structures are, in turn, influenced by everyday behavior. This dual approach allows for a richer, more complete understanding of society.

W.E.B. Du Bois argued that race is a social construction and introduced the concept of double consciousness to describe the experience of African Americans in a racially divided society. Drawing on Du Bois' ideas, explain how the concept of double consciousness might help us understand the experiences of a different marginalized group today.

Suggested answer: Sample response: W.E.B. Du Bois' concept of double consciousness describes how African Americans must constantly view themselves through their own perspective and through the eyes of a society that devalues them. This creates a sense of internal conflict and divided identity. Today, we can apply this idea to Muslim Americans, especially since 9/11. Many see themselves as proud citizens but are often viewed with suspicion due to stereotypes. For example, a Muslim student wearing a hijab might feel pressure to prove she belongs or hide parts of her identity to avoid judgment. Du Bois' concept helps explain how systemic discrimination affects not only opportunities but also how people see themselves. It shows that inequality shapes both social outcomes and inner experiences.

How does the Black Lives Matter movement challenge the social construction of inequality and power in the United States? In your answer, discuss how BLM works to address systemic racism, and provide one example of a similar movement (past or present) that also challenges inequality.

Suggested answer: Sample response: The Black Lives Matter (BLM) movement challenges the social construction of inequality by exposing how racism is built into U.S. institutions and maintained through dominant ideas that present society as fair and equal. BLM pushes back against the belief that police violence is just the result of a few bad actors. Instead, it highlights systemic racism—the idea that laws, policies, and institutions have historically disadvantaged Black communities. By organizing protests, raising awareness, and demanding reforms in policing and criminal justice, BLM shifts public understanding of race, justice, and power. A similar movement was the Civil Rights Movement, which fought racial segregation and discrimination in the mid-20th century. Like BLM, it used collective action to challenge unjust systems and reshape how Americans think about equality and justice.

How does a micro-level focus on social interactions help us understand how larger cultural norms and social roles are both created and maintained? Use an example to illustrate your answer.

Suggested answer: Sample response: Microsociology shows how society is built from the ground up through repeated, everyday social interactions. These small interactions help establish shared expectations and reinforce broader cultural norms. For example, the way people behave in a college classroom (e.g., raising hands to speak, taking notes, and listening quietly) all reflect agreed-upon roles of teacher and student. Over time, these patterns of behavior become taken for granted and institutionalized, forming the foundation for more complex social systems. Erving Goffman's idea of impression management illustrates this process, as individuals constantly adjust their behavior to fit the social role expected of them in a given setting. These role performances help reproduce norms and contribute to social stability, because they allow people to predict and coordinate their behavior with others. By analyzing everyday interactions, microsociology reveals how culture and order are not simply imposed from above but are actively constructed and maintained in daily life.

In what ways can studying sociology prepare students for success in today's job market and for active citizenship? Provide examples of the skills and knowledge sociology majors gain.

Suggested answer: *Sample response: Studying sociology prepares students to be thoughtful and engaged citizens while also equipping them with valuable workplace skills. Sociology majors learn how to gather and interpret data, understand social trends, and communicate findings clearly. These skills are useful in careers in business, government, nonprofits, and law. For example, someone working in marketing can use sociological knowledge to understand consumer behavior, while someone in public policy can use it to address social inequality. More broadly, sociology encourages critical thinking, cultural awareness, and a deeper understanding of social problems, all essential for making informed decisions and contributing to positive changes in society.*
