Q21. [Essay] · Cognitive Domain: Analysis

Summarize the functional approach to defining religion. Then, critique this definition using a substantive definition.

Suggested answer: Sample response: A functional approach focuses on what religion does or what religion accomplishes for adherents. This definition tends to be more inclusive of different religious forms, beliefs, and practices, and it focuses on the issue of meaning. Scholars in this tradition argue that religion is primarily concerned with providing purpose in life and addressing the meaning of death, suffering, and injustice. Such a definition tends to assume that all people have some religious tendencies, as this definition is broad enough to include systems of meaning such as science. A substantive definition focuses more narrowly on what religion is; as such, it categorizes a narrower range of worldviews as religious, as these definitions tend to emphasize the presence of a supernatural being or god(s), which something like science does not. Therefore, one critique would be that the functional definition is too broad and that it does not adequately separate religious beliefs and rituals from other types of beliefs and rituals.

The authors note that some scholars argue functional definitions of religion are too broad, rendering the concept of “religion” meaningless. Do you agree or disagree? Support your points with concepts from the first chapter.

Suggested answer: Sample response: Students might argue that the definition is too broad, arguing that belief in science/technology is different from belief in a supernatural being or power. They could contend that the questions of meaning, life, and death are not directly addressed by the scientific field but are adequately considered by worldviews coming from Christianity, Judaism, Islam, Buddhism, and more. On the other hand, they may point to invisible religion or lived religion as revealing the importance of having a broad definition of religion. If religion is focused on particular beliefs and rituals, then scholars may overlook the diverse ways people find and create meaning in their everyday lives.

Q23. [Essay] · Cognitive Domain: Analysis

How does Geertz define religion? How does this symbolic definition differ from substantive and functional definitions?

Suggested answer: Sample response: Geertz takes symbols as his starting point for his definition, arguing that symbols (objects, stories, and acts that represent another thing) powerfully impact our behaviors and are central to religion. Symbols allow followers to represent images, stories, and beliefs that are central to their worldviews. From there, he argues that these symbols work together to create a general explanation for existence that in turn shapes people's moods and motivations. In other words, some people may believe that presenting a particular mood is critical to being a good adherent of that faith tradition; people would then try to take on this mood. This definition tries to incorporate both substantive and functional definitions to get the best of both approaches; thus, there is the emphasis on what religious is (a system of symbols) and what it does (establishes moods and motivations).

What is invisible religion? How is invisible religion connected to modernity?

Suggested answer: Sample response: Thomas Luckmann defines invisible religion as private systems of belief that individuals create by drawing on many different sources, including diverse religions and other areas of life. He argued that religion should not be understood only as a macro system of meaning, but rather as embedded in a person's identity, dispositions, attitudes, and more. Invisible religion emerged with modernity as religious institutions became less influential in all areas of a person's life. While on the surface, this made it appear that people were less religious because they were not as connected to religious institutions, Luckmann argues that invisible religion proliferates as religiosity takes on new forms.

What is lived religion? What are some challenges of studying lived religion?

Suggested answer: Sample response: Lived religion refers to how people actually experience and practice religion in their everyday lives. This approach focuses on understanding how religion surfaces in many areas of life, not just in the institution of religion or in the form of prescribed beliefs. One challenge of studying lived religion is that scholars may not know where to look or what questions to ask, since they are starting from the assumption that people's religious beliefs and practices will depend on the person. Scholars developed innovative methods—such as using photo elicitation—to try to capture firsthand what religion means to different people.

What does it mean to say "I am spiritual, but not religious?" What assumptions are embedded in this phrase?

Suggested answer: Sample response: There has been an increase in the percentage of people who say they are spiritual but not religious. What this usually means is that they see spirituality as an individual way to connect with the divine, and they see religion as more imposing, external, and group-based. Embedded in this phrase are several assumptions, including: that spirituality is separate from religion, which historically has not been the case; and that spirituality is a more isolated experience whereas religion is more communal, when in reality spirituality can be produced and located in other social institutions.

Provide your own definition of religion, citing beliefs, rituals, meanings, and symbols as appropriate. How might a sociologist with a different definition critique yours?

Suggested answer: Sample response: One definition of religion could be: a worldview that gives meaning to symbols, has specific goals and hopes for the future, and provides for the formation of a community. In that way, all major world religions are encompassed in this definition, as well as smaller religious groups like Wicca that operate in online spaces. However, a critique of this would be that it is too broad and does not give any specific reference to the concept of a divine or supernatural.

Drawing on the text, explain why it is necessary to interrogate definitions of religion.

Suggested answer: Sample response: It is important to interrogate definitions of religion because all definitions have embedded in them implicit assumptions. Furthermore, how religion is defined will shape what behaviors or beliefs are seen as appropriate areas of study for sociologists of religion. Therefore, being explicit about what assumptions one is making in defining religion allows readers to better understand the scholar's perspective and focus.
