Briefly explain the significance of the People's Will in Russia.

**Suggested answer:** Sample response: The ideological origins of modern left-wing terrorism can be traced to the movements in the 19th century, when communist and anarchist idealists advocated for the downfall of imperial and capitalist society. The People's Will in Russia was a direct byproduct of the student dissatisfaction with the czarist regime. Russian college students were taught Marxism and anarchism philosophies. The People's Will was a conspiratorial terrorist organization, which became one of the first examples of revolutionary vanguard strategy. They carefully planned out violence against government officials resulting in the central state installing a repressive police state who imprisoned and harassed the memories of People's Will.

New Terrorism skillfully uses social media and the Internet, manipulating mass media, while traditional terrorism has carefully selected targets.

**Suggested answer:** Sample response: Lone wolves are individual extremists and use a low degree of criminal sophistication. Lone wolves like Tarrant ? who was a white racial supremacist who killed Muslim worshippers in two mosques in New Zealand ? are racially or ideologically motivated to commit killing sprees and are not acting on behalf of an organized group.

How can the "just war doctrine" be applied to the actions of the Roman Empire?

**Suggested answer:** Sample response: The Roman Empire felt as though their cause of brutal suppression was just and right and their enemies' cause was unjust. Romans crucified rebels who opposed Roman authority as a form of public execution, while Roman citizens were exempt from being crucified. This is an example of *jus ad bellum*, or having the right conditions of waging war. Crucifixion and other violent methods used by the Roman Empire are examples of *jus in bello* or the correct conditions during the war.

Discuss the four characteristics associated with terrorism from a layperson's point of view.

**Suggested answer:** Sample response: Terrorism is the utilization of politically motivated violence, typically directed against soft targets such as civilians. Terrorism communicates messages to a larger group and has the intention to terrorize or affect a target audience.

How might nations justify politically motivated violence?

**Suggested answer:** Sample response: Nations can use justified politically motivated violence through *mala prohibita* and *mala in se* acts. *Mala prohibita* acts are behaviors that become illegal through legislation such as gambling and prostitution. The state takes the moral high ground and the position that state violence is justified to combat evil actions. *Mala in se* acts are universally immoral behaviors such as murder. For example, if opposing groups against the state are committing murders, then nations can justify politically motivated violence to maintain public order.

Behavior that we now define as terrorism is historically ancient. However, examples from the French Revolution and 19th-century Europe were arguably immediate precedents for modern terrorism. Why were these historical behaviors considered to be terrorism? Explain your answer.

**Suggested answer:** Sample response: During the French Revolution, the term terrorism was coined to describe the Reign of Terror. Many opponents of the radical Jacobin-dominated French state were put on trial, also known as the Revolutionary Tribunal, and then executed by the guillotine. The Reign of Terror is a good example of state terrorism. Another example was the Luddites, who were 19th century English workers who opposed economic and state transformation of the Industrial Revolution. The Luddites sabotaged textile and weaving machinery in protest. These acts disrupted the textile industry in England. Finally, the People's Will in Russia were radical reformists who promoted ideals of Marxism and anarchism. These radicals committed terroristic violent behaviors such as shootings and bombings against government officials to drive out the czarist regime.

Provide some examples of terrorist attacks and explain how the significance of symbolism is applied to them.

**Suggested answer:** Sample response: Symbolism creates abstract ideological associations between terrorists and their targets. For example, the Irish Republican Army's (IRA) assassination of Lord Louis Mountbatten symbolized enemy political or social establishments. Another example is the 1970s Latin American leftists who kidnapped business executives and government diplomats who symbolized capitalism and exploitation.

Since New Terrorism significantly differs from traditional terrorism, nations must consider different warlike options. Nations have had to cooperate with other states to disrupt terrorist cells in various countries in different continents. Due to the new information technologies and the Internet, those engaging in the "war on terrorism" need to be equipped with cybersecurity measures and software to combat New Terrorism.

**Suggested answer:** Sample response: Brenton Harrison Tarrant was an Australian racial supremacist who attacked two Muslim mosques in New Zealand. Ramzi Yousef was an international terrorist who was behind the 1993 World Trade Center bombing. Tarrant used a low degree of criminal sophistication as a lone wolf who believed in a specific ideology but not a part of an organized group. Yousef used a high degree of criminal organization as he meticulously planned his actions. He had connections to well-funded terrorists, knew how to make bombs and obtain the materials in a foreign country, and was adept at evasion. Both were captured and answered to their crimes.

**Suggested answer:** Sample response: The rise of the nation-state in the mid-17th century caused a change from open warfare to guerrilla warfare, insurgency, and terrorism. Before the rise of the nation-state, medieval warfare consisted of openly brutal warfare such as invasions driven by political discord between leaders and religious intolerance. After the rise of the nation-state, historical events such as the French Revolution represented the evolution of warfare behavior.

**Suggested answer:** Sample response: Extremism is a radical assertion of one's political values. The concept of extremism should be analyzed through the content of one's values and the style of how that person expresses their beliefs. One should analyze how one expresses their beliefs and which belief one acts upon. Extremism can lead one to commit terrorist acts which they use specific values to justify violent behavior. Terrorists may use these violent acts to communicate their extremist belief to a larger group.

As a result, terrorists can excuse political violence through labeling human targets who as a result become dehumanized and objectified as terrorists craft symbolic meaning from violent acts.

Terrorism is the use of violence motivated by politics, typically directed against soft targets such as civilians, which is used to communicate a message to a large group with the intention to terrorize a target audience. Terrorist acts are an expression of extremist thoughts.

Criteria for if a war is just are divided into *jus ad bellum* (justice of war), *jus in bello* (justice in war), and *jus post bellum* (justice after war). The *jus ad bellum* is the radical state having power after overthrowing the previous regime. The *jus in bello* is the guillotine that was responsible for many executions during the Reign of Terror.

**Suggested answer:** Sample response: The modern Hamas movement is a “freedom fighting” movement who have applied the just war doctrine. Hamas consider their cause as just and methods used appropriate relative to the actions of their oppressors. Hamas believes they are freedom fighters who are waging a just war and allude to the Koran. An example of a terrorist movement is the Roman Empire expansion. To showcase Roman authority, rebels were crucified. In conquered territories, the Romans used violent terrorist behaviors to demonstrate that there would be no mercy against those who went against Roman rule. Both movements thought that their causes were just. The Hamas movement was trying to fight against oppressors, while the Roman Empire were the oppressors who conquered territories.

Provide an example of how new information technologies and the Internet have created unprecedented opportunities for terrorist groups.

**Suggested answer:** Sample response: New Terrorism is characterized by using the Internet and social media and manipulating mass media. These new information technologies allow terrorists to bring their wars to many people. Cycles of violence such as mass casualty attacks are reported online which raises global awareness. For example, Brenton Harrison Tarrant live streamed his first attack on Facebook after uploading his manifesto online. This communicated his extremist beliefs and actions to a global audience.
