What are the similarities and differences between criminology and victimology?

Suggested answer: Sample response: In criminology, one studies criminals—what they do, why they do it, and how the criminal justice system responds to them. In victimology, one studies crime victims—the causes of victimization, consequences of victimization, and how the criminal justice system deals with victims. Additionally, victimologists explore how others, including the media, also deal with crime victims. Both fields of study use the scientific method to explore their groups and neither would be able to fully understand itself without considering the impact of the other. Victimology is considered a subfield of criminology.

How did the “father of criminology” classify crime victims?

Suggested answer: Sample response: Benjamin Mendelsohn had six levels of victim culpability when studying crime victims. The completely innocent victim is one who is not responsible at all for the offense. The victim with minor guilt is one who acts irresponsibly and places himself in harm's way inadvertently. The victim who was as guilty as the offender or was a voluntary victim is a victim who is just as responsible as an offender for a crime. The victim who was more guilty than the offender is the one who provokes an incident to occur. The most guilty victim is one who perpetrates a crime and is harmed in the process. The simulating or imaginary victim is one who has not been victimized but instead fabricates an incident.

How are the 1980 President's Task Force on Victims of Crime and the 1998 *New Directions From the Field: Victims' Rights and Services for the 21st Century* related to each other?

Suggested answer: Sample response: *New Directions from the Field* is a follow-up on the President's Task Force on Victims of Crime. The purpose of *New Directions* was to see what recommendations were followed from the 1980 report and to identify areas that still needed improvement. The *New Directions From the Field: Victims' Rights and Services for the 21st Century* identified some 250 new recommendations for victims' rights, victim advocacy, and services

Why is the work of Hans von Hentig important in the study of victimology?

Suggested answer: Sample response: He attempted to identify the characteristics of a victim that may effectively serve to increase victimization risk. He considered that victims may provoke victimization—acting as agents provocateurs—based on their characteristics. He argued that crime victims could be placed into 1 of the 13 categories based on their propensity for victimization: (1) young, (2) females, (3) old, (4) immigrants, (5) depressed, (6) mentally defective/deranged, (7) the acquisitive, (8) dull normals, (9) minorities, (10) wanton, (11) the lonesome and heartbroken, (12) tormentor, and (13) the blocked, exempted, and fighting. All these victims are targeted and contribute to their own victimization because of their characteristics.

What are the three key developments that arose from the Women's Movement?

Suggested answer: Sample response: First, the movement brought awareness that victimization often entails emotional and mental harm, even in the absence of physical injury. To address this harm, counseling for victims was advocated. Second, the criminal justice system was no longer relied on to provide victims with assistance in rebuilding their lives; thus additional victimization by the criminal justice system could be lessened or avoided altogether. Third, because these shelters and centers relied largely on volunteers, services were able to run and stay open without significant budgetary support.
