Explain what is meant by the brutalization hypothesis.

Suggested answer: Sample response: There is evidence that the death penalty may not deter crime and may actually increase homicide levels in areas where executions occur. This observation is based on the notion that violence begets violence and is referred to as the brutalization hypothesis. This hypothesis contends that the death penalty may actually cause an increase in murders because it reinforces the use of violence.

Explain why defining violence is so difficult.

Suggested answer: Sample response: There are many reasons why it is so difficult to define violence. For one, people understand violence in their own way. It is based on their individual history and the context of their life. Furthermore, many people often only use the term “violence” to refer to physical acts of aggression, but it can also include emotional and psychological acts. In addition, some people only see violence as acts committed by people, while others recognize that natural disasters can also be violent.

Provide a scenario and explain the circumstances where the actions could be perceived as violent behavior versus nonviolent behavior.

Suggested answer: Sample response: In the first scenario, assume an individual gets hit by a car. Things to consider would be if the act was intentional (violent) or unintentional (nonviolent) or whether the driver was following traffic laws (nonviolent) or not (violent).

Explain the strengths and weaknesses of the Uniform Crime Report and the National Crime Victimization Survey.

Suggested answer: Sample response: The strength of the UCR is that it has collected information about criminal incidents reported to the police since 1930, providing trends over place and time. Moreover, a lot of agencies participate, so there is high coverage. Some weaknesses are that measurements may not always be accurate because it only considers crimes to the police. Moreover, police may underestimate crime for political reasons. Furthermore, the UCR only counts the most serious crime that occurred at an incident. Some strengths of the NCVS include measuring unreported crime, providing victimization rates over time, and gathering additional information related to victimizations. Some of the weaknesses of the NCVS include that it only includes data on households—therefore, victimizations that occur in business are not included, nor are those that occur among people experiencing homelessness. It also only includes victimizations of people 12 years and older, neglecting victimizations of younger people.

What information do self-reported data sets provide about criminal behavior that is not captured by official data sets on crime? Why are these studies important in providing an accurate picture of criminal offending?

Suggested answer: *Sample response: Official data sets involve data from official sources, usually arrest data. Although these data sets allow for a partial picture of crime, self-report studies can add additional information that is not captured by those data sets. Self-report studies allow us to see criminal behaviors that have not been officially reported. These data can be used to identify at-risk populations, provide details about particular populations, and shed light on potential prevention or intervention techniques to criminal offending. Longitudinal self-report studies also allow for offending behaviors to be studied over a period of time with the same individuals.*
